

What are Standing Orders?

Standing Orders are the written rules of a local council. They are used to confirm a council's internal organisational, administrative and procurement procedures and procedural matters for meetings. They are not the same as the policies of a council but they may refer to them.

A local council must have Standing Orders for the procurement of contracts. Meetings of full council, councillors, the Responsible Financial Officer and Proper Officer (at Holybrook Parish Council these job rolls are encapsulated under one job title of Clerk) are subject to many statutory requirements. A council should have Standing Orders to confirm those statutory requirements. A council should have Standing Orders to control the number, place, quorum, notices and other procedures for committee and sub-committee meetings because these are subject to fewer statutory requirements. If it does not, committees and subcommittees may adopt their own Standing Orders.

The Standing Orders that are in **bold** contain statutory requirements. Standing Orders that are not in bold are designed to help councils operate effectively but do not contain statutory requirements so they may be adopted as drafted or amended to suit a council's needs.

The Standing Orders do not include the Financial Regulations. Financial Regulations are Standing Orders to regulate and control the financial affairs and accounting procedures of a local council. The Financial Regulations, as opposed to the Standing Orders of a council, include most of the requirements relevant to the Responsible Financial Officer.

Definitions and Meanings

- a) Christmas Break means Christmas day, Boxing Day and any bank holiday in substitution for such a day.
- b) Easter break means Good Friday, Easter Saturday and Easter Monday.
- c) Committee shall include sub-committee.
- d) Chairman shall include Vice Chairman.

The Parish Council has adopted the National Code of Local Government Conduct, to indicate the standards expected and the manner in which the standing orders should be applied. Some minor adjustments have been made. In Part One, key legislation is highlighted in **bold type**.

1 Meetings

*	a)	Meetings shall not take place in premises, which at the time of the meeting, are used for the supply of alcohol unless no other premises are available free of charge or at a reasonable cost.
**	b)	When calculating the minimum 3 clear days for notice of a meeting to councillors and the public, the day on which notice was issued, the day of the meeting, a Sunday, a day of the Christmas break, a day of the Easter break or of a bank holiday or a day appointed for public thanksgiving or mourning shall not count.
**	c)	Meetings shall be open to the public unless their presence is prejudicial to the public interest by reason of the confidential nature of the business to be transacted or for other special reasons. The public's exclusion from all or part of a meeting shall be by a resolution which shall give reasons for the public's exclusion.
	d)	Subject to Standing Order 1(c) above, members of the public are permitted to make representations, answer questions and give evidence in respect of any item of business included in the agenda. There will be an allotted section on the agenda to enable this.
	e)	The period of time (which is at the Chairman's discretion) OR (which is designed for public participation in accordance with Standing Order 1(d) above) shall not exceed 20 minutes.
	f)	Subject to Standing Order 1(e) above, each member of the public is entitled to speak once only in respect of business itemised on the agenda and shall not speak for more than 5 minutes.
	g)	In accordance with Standing Order 1(d) above, a question asked by a member of the public during a public participation session at a meeting, shall not require a response or debate.
	h)	In accordance with Standing Order 1(g) above, the Chairman may direct that a response to a question posed by a member of the public be referred to a Councillor for an oral response or to an employee for a written or oral response.
	i)	A record of a public participation session at a meeting shall be included in the minutes of that meeting.
	j)	[A person shall raise their hand when requesting to speak and stand when speaking (except when a person has a disability or is likely to suffer discomfort)]. The Chairman may, at any time, permit an individual to be seated when speaking.
	k)	Any person speaking at a meeting shall address their comments to the Chairman.
	I)	Only one person is permitted to speak at a time. If more than one person wishes to speak, the Chairman shall direct the order of speaking.
**	m)	Photographing, recording, broadcasting or transmitting the proceedings of a meeting by any means is permitted. Permission must be sought before the meeting commences. The Chairman's decision is final. (see appendix 1).
**	n)	In accordance with Standing Order 1(c) above, the press shall be provided reasonable facilities for the taking of their report of all or part of a meeting at which they are entitled to be present.
*	0)	Subject to Standing Orders which indicate otherwise, anything authorised or required to be done by, to or before the Chairman may in their absence may be done by, to or before the Vice-Chairman of the Council (if any).
*	p)	The Chairman, if present, shall preside at a meeting. If the Chairman is absent from a meeting, the Vice-Chairman, if present, shall preside. If both the Chairman and the Vice-Chairman are absent from a meeting, a Councillor, as chosen by the Councillors present at the meeting, shall preside at the meeting.
***	q)	Subject to Standing Order 1(s) below, all questions at a meeting shall be decided by a majority of the Councillors present and voting thereon.

***	r)	The Chairman may give an original vote on any matter put to the vote, and in the case of an equality of votes may exercise their casting vote whether or not he gave an original vote. (See also Standing Orders 2(h) and (i) below).
*	s)	Unless Standing Orders provide otherwise, voting on any question shall be by a show of hands. At the request of a Councillor, the voting on any question shall be recorded so as to show whether each Councillor present and voting gave their vote for or against that question. Such a request shall be made before moving on to the next item on the agenda.
***	t)	 The minutes of a meeting shall include an accurate record of the following: i. The time and place of the meeting; ii. the names of the Councillors present and absent; iii. whether a councillor or non-councillor with voting rights left the meeting when matters that they held interests in were being considered; iv. if there was a public participation session; and v. the resolutions made.
***	u)	The Code of Conduct adopted by the Council shall apply to Councillors in respect of the entire meeting. A Councillor or non-councillor with voting rights who has a disclosable pecuniary interest or other interest as set out in the Council's Code of Conduct in a matter being considered at a meeting is subject to statutory mitigations and restrictions under the Code on their right to participate and vote on that matter.
***	v)	An interest arising from the Code of Conduct adopted by the Council, the existence and nature of which is required to be disclosed by a Councillor at a meeting shall be recorded in the minutes. (See also Standing Orders 7 & 8 below).
***	w)	No business shall be transacted at a meeting unless at least one third of the whole number of members of the Council are present.
***	x)	If a meeting is, or becomes, inquorate no business shall be transacted and the meeting shall be adjourned. Any outstanding business of a meeting so adjourned shall be transacted at a following meeting or on such other day as the Chairman may fix.
***	y)	Meetings shall not exceed a period of 2.5 hours. Unless where the Council vote to continue. This will be by a show of hands (see also Standing Order 1r above)

а	Unless there is a Council resolution to the contrary, every committee may appoint a sub- committee whose Terms of Reference and members shall be determined by resolution of the committee.	
b	The	Council appoint standing committees and such other committees as may be necessary, and:
	i	shall determine their Terms of Reference;
	ii	may permit committees to determine the dates of their meetings;
	iii	shall appoint and determine the term of office of councillor or non-councillor members of such a committee (unless the appointment of non-councillors is prohibited by law) so as to hold office no later than the next annual meeting;
	iv	may appoint substitute councillors to a committee whose role is to replace ordinary councillors at a meeting of a committee if ordinary councillors of the committee have confirmed to the Proper Officer two days before the meeting that they are unable to attend;
	v	an ordinary member of a committee who has been replaced at a meeting by a substitute member (in accordance with Standing Order 2(b)(iv) above, shall not be permitted to participate in debate or vote on business at that meeting and may only speak during any public participation during the meeting;
	vi	May, in accordance with Standing Orders, dissolve a committee at any time.
	vii	The members of a committee may include non-councillors unless it is a committee which regulates and controls the finances of the Council.
С		The Council may appoint advisory committees comprised of a number of councillors and non-councillors.
d		Advisory committees and any sub-committees may consist wholly of persons who are non-councillors.

3 Extraordinary meetings See also Standing Order 1 above

а	The Chairman of the Council may convene an extraordinary meeting of the Council at any time.
b	If the Chairman of the Council does not, or refuses to, call an extraordinary meeting of the Council within 7 days of having been requested to do so by two Councillors, those two Councillors may convene an extraordinary meeting of the Council. The statutory public notice giving the time, venue and agenda for such a meeting must be signed by the two Councillors.
С	The Chairman of a committee (or sub-committee) may convene an extraordinary meeting of the committee or sub-committee at any time.
d	If the Chairman of a committee (or sub-committee) does not or refuses to call an extraordinary meeting within 7 days of having been requested by to do so by two Councillors, those two Councillors may convene an extraordinary meeting of a committee (or sub-committee). The statutory public notice giving the time, venue and agenda for such a meeting must be signed by 2 Councillors.

4 Motions requiring written notice

а	A motion shall relate to the responsibilities and performance of the Council's statutory functions, powers and obligations or on an issue which specifically affects the Council's area or its residents.
b	In accordance with Standing Order 24(b)(iii) below, no motion may be moved at a meeting unless it is included on the agenda and the mover has given written notice of its wording to the Council's Proper Officer at least 10 clear days before the next meeting.
С	The Proper Officer may, before including a motion in the agenda received in accordance with Standing Order 4(a) above, correct obvious grammatical or typographical errors in the wording of the motion.
d	If the Proper Officer considers the wording of a motion received in accordance with Standing Order 4(a) above is not clear in meaning, the motion shall be rejected until the mover of the motion resubmits it in writing to the Proper Officer in clear and certain language at least 7 clear days before the meeting.
е	If the wording or subject of a proposed motion is considered unlawful or improper, the Proper Officer shall consult with the Chairman of the forthcoming meeting or, as the case may be, the Councillors who have convened the meeting, to consider whether the motion shall be included or rejected from the agenda.
f	Having consulted the Chairman or councillors pursuant to Standing Order 4(c) above, the decision of the Proper Officer as to whether or not to include the motion in the agenda shall be final.
g	Notice of every motion received in accordance with the Council's Standing Orders shall be numbered in the order received and shall be entered in a book, which shall be open to inspection by all councillors.
h	Every motion rejected, in accordance with the Council's Standing Orders, shall be recorded with a note by the Proper Officer giving reasons for its rejection.

6 Rules of Debate

а	Motions on the agenda shall be considered as they appear unless the order is changed at the Chairman's direction for reasons of expedience.		
b	Subject to Standing Orders 4(a)-(e) above, a motion (including any amendments) shall not be progressed unless it has been proposed and seconded.		
С	Subject to Standing Order 24(b)(iii) above, a motion included on an agenda not moved by the Councillor who tabled it, may be treated as withdrawn.		
е	A Councillor may move amendments to their own motion. If a motion has already been seconded, an amendment to it shall be with the consent of the seconder.		
f	Any amendment to a motion shall be either:		
	i to leave out words;		
	ii to add words;		
	iii to leave out words and add other words.		
g	A proposed or carried amendment to a motion shall not have the effect of rescinding the original or substantive motion under consideration. If an amendment to the original motion is carried, the original motion (as amended) becomes the substantive motion upon which further amendment(s) may be moved.		
h	Only one amendment shall be moved and debated at a time, the order of which shall be directed by the Chairman. No further amendment to a motion shall be moved until the previous amendment has been disposed of.		
i	Subject to Standing Order 6(h) above, one or more amendments may be discussed together if the Chairman considers this expedient but shall be voted upon separately.		

j		Pursuant to Standing Order 6(h) above, the number of amendments to an original or substantive motion, which may be moved by a Councillor, is limited to one.		
k		If an amendment is not carried, other amendments shall be moved in the order directed by the Chairman.		
m	The mover of a motion or the mover of an amendment shall have the right of reply, not exceeding 3 minutes.

9 Disorderly conduct

а	No person shall obstruct the transaction of business at a meeting or behave offensively or improperly. If this Standing Order is ignored, the Chairman of the meeting shall request such person(s) to moderate or improve their conduct.
b	If, in the opinion of the Chairman, there has been a breach of Standing Order 9(a) above, the Chairman shall express that opinion and, thereafter, any Councillor (including the Chairman) may move that the person be silenced or excluded from the meeting, and the motion, if seconded, shall be put forthwith and without discussion.
С	If a resolution made in accordance with Standing Order 9(b) above, is disobeyed, the Chairman may take further reasonable steps necessary to enforce it and/or may adjourn the meeting.

10 Rescission of previous resolutions

а	A resolution (whether affirmative or negative) of the Council shall not be reversed within 6 months except either by a special motion, the written notice whereof bears the names of at least two thirds of the members of the Council, or by a motion in pursuance of the report or recommendations of a committee.
b	When a special motion or any other motion moved pursuant to Standing Order 10(a) above has been disposed of, no similar motion may be moved within a further 6 months.

11 Voting on appointments

Where more than two persons have been nominated for a position to be filled by the Council and none of those persons has received an absolute majority of votes in their favour, the name of the person having the least number of votes shall be struck off the list and a fresh vote taken. This а process shall continue until a majority of votes is given in favour of one person. Any tie may be settled by the Chairman's casting vote.

12 Canvassing of and recommendations by councillors

а	Canvassing councillors or the members of a committee or sub-committee, directly or indirectly, for appointment to or by the Council shall disqualify the candidate from such an appointment. The Proper Officer shall disclose the requirements of this Standing Order to every candidate.
b	A Councillor or a member of a committee or sub-committee shall not solicit a person for appointment to or by the Council or recommend a person for such appointment or for promotion; but nevertheless any such person may give a written testimonial of a candidate's ability, experience or character for submission to the Council with an application for appointment.

A Councillor may, for the purpose of their official duties (but not otherwise), inspect any document in the possession of the Council or a committee or sub-committee, and request a copy for the same purpose. The minutes of meetings of the Council, its committees or sub-committees shall be available for inspection by councillors. Exception: A Member shall not knowingly inspect nor call for a copy of any document relating to a matter where:

- they are professionally interested;
- they have directly or indirectly an interest;

• The document is or in the event of legal proceedings, would be protected by privilege arising out of the relationship of solicitor and client or where sight of any document might be prejudicial to the interests or justice or impartiality in any legal proceedings or pending legal proceedings including disciplinary matters.

14 Unauthorised activities

а		ss authorised by a resolution, no individual councillor shall, in the name or on behalf of the cil, a committee or sub-committee:
	i	inspect any land and/or premises which the Council has a right or duty to inspect; or
	ii	Issue orders, instructions or directions.

15 Confidential business

а	Councillors shall not disclose information given in confidence or which they believe, or ought to be aware, is of a confidential nature.
b	A Councillor in breach of the provisions of Standing Order 24(a) above may be removed from a committee or a sub-committee by a resolution of the Council.

16 Questions

а	A Councillor may seek an answer to a question concerning any business of the Council provided 4 clear days notice of the question has been given to the Proper Officer in writing. Or, in case of urgency, not later than 10.00am on the day of the meeting.
b	A Member may, with or without notice, ask the Chairman of a Committee any question upon the proceedings of the Committee then before the Council if the question is put before the Council's consideration of those proceedings is finished.
С	Every question shall be put and answered without discussion.

A person to whom a questions has been put may decline to answer or nominate another person to answer or defer to a relevant document or provide a written reply when a reply cannot conveniently be given orally.

17 Minutes

а	If the draft minutes of a preceding meeting have been served on councillors no later than the day of service of the summons to attend the scheduled meeting at which they are due to be approved for accuracy they shall be taken as read.
b	No discussion of the draft minutes of a preceding meeting shall take place except in relation to their accuracy. A motion to correct an inaccuracy in the draft minutes shall be moved in accordance with Standing Order 5(a) (iv) above.
С	Minutes, including any amendment to correct their accuracy, shall be confirmed by resolution and shall be signed by the Chairman of the meeting and stand as a correct record of the meeting to which the minutes relate.
d	If the Chairman of the meeting does not consider the minutes to be an accurate record of the meeting to which they relate, they shall sign the minutes and include a paragraph in the following terms or to the same effect: "The Chairman of this meeting does not believe that the minutes of the meeting of the () held
	on [date] in respect of () were a correct record but their view was not upheld by the majority of the meeting and the minutes are confirmed as an accurate record of the proceedings."
е	Upon a resolution which confirms the accuracy of the minutes of a meeting, any previous draft minutes or recordings of the meeting shall be destroyed.

18 General Power of Competence *

а	Before exercising General Power of Competence, a meeting of the full Council shall have passed a resolution to confirm it has satisfied the prescribed statutory criteria required to qualify as an eligible parish council.	
b	The Council's period of eligibility begins on the date that the resolution under Standing Order 25(a) above was made and expires on the day before the annual meeting of the Council that takes place in a year of ordinary elections.	
С	After the expiry of its preceding period of eligibility, the Council continues to be an eligible council solely for the purpose of completing any activity undertaken in the exercise of the power to promote well-being which was not completed before the expiry of the Council's preceding period of eligibility referred to in Standing Order 25(b) above.	

FINANCE

19 Expenditure

а	Any expenditure incurred by the Council shall be in accordance with the Council's financial regulations.
b	The Council's financial regulations shall be reviewed once a year.

20 Execution and sealing of legal deeds

а	A legal deed shall not be executed on behalf of the Council unless the same has been authorised by resolution.
b	In accordance with a resolution made under Standing Order 14(a) above, any two members of the Council may sign, on behalf of the Council, any deed required by law and the Proper Officer shall witness their signatures.

21 Accounts and Financial Statement

а	All payments by the Council shall be authorised, approved and paid in accordance with the Council's financial regulations (which shall be reviewed at least annually).
b	The Responsible Financial Officer shall supply, to each Councillor as soon as practicable after 31st March, 30th June, 30th September and 31st December, in each year a statement to summarising: the Council's receipts and payments for each quarter and the balances held at the end of a quarter. This statement should include a comparison with the budget for the financial year. A Financial Statement prepared on the appropriate accounting basis (receipts and payments, or income and expenditure) for a year to 31st March shall be presented to each Councillor before the end of May. The Statement of Accounts of the Council (which is subject to external audit), including the Annual Governance Statement, shall be presented to Council for formal approval before 30th June.

22 Estimates/Precepts

а	The Council shall approve written estimates according to the current Financial Regulations.
b	Any committee desiring to incur expenditure shall give the Proper Officer a written estimate of the expenditure recommended for the coming financial year no later than the end of September .

23 Financial Controls & Procurement

а	The Council's Proper Officer shall be either (i) the Clerk or such other employee as may be nominated by the Council from time to time or (ii) such other employee appointed by the Council to undertake the role of the Proper Officer during the Proper Officer's absence. The Proper Officer and the employee appointed to act as such during the Proper Officer's absence shall fulfil the duties assigned to the Proper Officer in Standing Orders.

xiv	Arrange for legal deeds to be signed by two councillors and witnessed.
xv	Arrange for the prompt authorisation, approval, and instruction regarding any payments to be made by the Council in accordance with the Council's financial regulations.
xvi	Record every planning application notified to the Council and the Council's response to the local planning authority.
xvii	Refer a large or complex planning application received by the Council to the Chairman of the Council, or in their absence the Chairman of the Planning Committee, within 2 working days of receipt to facilitate an extraordinary meeting if the nature of a planning application requires consideration before the next ordinary meeting of the Council or the Planning Committee.
xvii	Action or undertake activity or responsibilities instructed by resolution or contained in Standing Orders.

25 Matters affecting council employees

g	The Council shall keep written records relating to employees secure. All paper records shall be stored under lock and electronic records shall be password protected.
f	Any persons responsible for all or part of the management of Council employees shall keep written records of all meetings relating to their performance and capabilities, grievance and disciplinary matters.
е	Subject to the Council's policy regarding the handling of grievance and disciplinary matters, if an informal or formal grievance matter raised by the Clerk relates to the Chairman or Vice-Chairman of the Council this shall be communicated to another two members of the Council Any subsequent action follows the formal grievance procedure.
d	Subject to the Council's policy of handling grievance matters, the Council's most senior employee (or other employees) shall contact the Chairman (or Chairman of the delegated committee) or in their absence, the Vice-Chairman (as above) in respect of an informal or formal grievance matter, and this matter shall be reported back and progressed by resolution of the Council or delegated committee.
С	The Chairman of the council or delegated committee, or in their absence, the Vice-Chairman shall, upon a resolution, conduct a review of the performance and/or appraisal of the employees' against their job description, and shall produce a written record of it. The review and/or appraisal shall be reported back and shall be subject to approval by resolution of the Council.
b	Subject to the Council's policy regarding absences from work, the Council's most senior employee shall notify the Chairman of Council or, in their absence, the Vice-Chairman, of any absence occasioned by illness or urgency and that person shall report such absence to the Council at its next meeting.
а	If a meeting considers any matter personal to a Council employee, it shall not be considered until the Council or the delegated committee or sub-committee has decided whether or not the press and public shall be excluded pursuant to Standing Order 1(c) above.

h	Records documenting reasons for an employee's absence due to ill health or details of a medical condition shall be made available only to those persons with responsibility for the same.
i	Only persons with line management responsibilities shall have access to employee records referred to in Standing Orders 26(g) and (h) above if so justified.
j	Access and means of access by keys and/or computer passwords to records of employment referred to in Standing Orders 26(g) and (h) above shall be provided only to (post holder) and/or the Chairman of the Council or a nominated Councillor.

OTHER

26 Responsibilities to provide information & Responsibilities under data protection regulations

а	All requests for information held by the Council shall be processed in accordance with the Council's policy in respect of handling requests under freedom of information legislation.
b	Correspondence from, and notices served by, the Information Commissioner shall be referred by the Proper Officer to the Chairman. The Council shall have the power to do anything to facilitate compliance with the Freedom of Information Act 2000 and the General Data Protection Regulation including exercising the powers of the Proper Officer in respect of Freedom of Information requests set out under Standing Order 3(b)(x) above.
С	The Council shall publish information in accordance with requirements of the Local Government (Transparency Requirements) (England) Regulations 2015.
	The Council will hold and publish procedures relating to Data Protection regulations.

27 Relations with the press/media

а	All requests from the press or other media for an oral or written statement or comment from the Council, its councillors or staff shall be processed in accordance with the Council's policy in respect of dealing with the press or other media.
b	In accordance with the Council's policy in respect of dealing with the press and/or other media, councillors shall not, in their official capacity, provide oral or written statements or written articles to the press or other media.

28 Liaison with District and County or Unitary Councillors

а	An invitation to attend a meeting of the Council shall be sent, together with the agenda, to the Councillor of the District and County or Unitary Council representing its electoral ward.
b	Unless the Council otherwise orders, a copy of each correspondence sent to the District or County or Unitary Council shall be sent to the District of County or Unitary Council councillor representing its electoral ward.

29 Variation, revocation and suspension of Standing Orders

а	Any or every part of the Standing Orders, except those which are mandatory by law, may be suspended by resolution to any specific item of business.
b	A motion to add or vary or revoke one or more of the Council's Standing Orders, not mandatory by law, shall be proposed by a special motion, the written notice whereof bears the name of at least (3) Councillors.

30 Standing Orders to be given to Councillors

1	a	The Proper officer shall provide a copy of the Council's Standing Orders to a Councillor upon delivery of their Declaration of Acceptance of Office.
	b	The Chairman's decision as to the application of Standing Orders at a meeting shall be final.
	С	A Councillor's failure to observe Standing Orders more than three times in one meeting shall result in them being excluded from the meeting in accordance with Standing Orders.

Appendix 1 Standing Orders/Guidance to members of the public

The purpose of these Standing Orders is to provide guidance for members of the press, or public, on the taking of photographs and/or the audio/visual recording of any Council meeting which is held in public.

Social Media

There are no restrictions on anyone at a Council meeting using Twitter, blogs, Facebook or similar social media provided that the Chairman does not consider their actions are disrupting the proceedings of the meeting.

If the Chairman feels the use of social media is disrupting the proceedings the Councillor, member of the public or media present using social media may be required to stop. If use continues the Chairman will ask the person to leave the meeting. If the person refuses to leave then the Chairman may adjourn the meeting or make other appropriate arrangements for the meeting to continue without disruption.

Audio and Visual Recording

Audio and visual recordings and reporting of proceedings by the media and general public of a meeting of the Council and its Committees are permitted. However, it would be helpful if those wishing to record could contact the Council before the meeting so that it can be ensured the necessary facilities are in place.

It would be helpful for the request to include the following information:

- a) which meeting the request refers to
- b) the name, organisation (if applicable) and contact details of the person making the request
- c) what equipment it is intended will be used (to determine what facilities might be required)
- d) what the photographs, or audio/visual recording will be used for and/or where the information is to be published (this is helpful for the Chairman to be able to inform the public).

Any equipment required for recording purposes should be set up before the meeting starts to avoid disturbance.

The Chairman of the meeting will advise the public that the meeting is being recorded.

A request to record a meeting shall only be refused if the Chairman believes that the recording will be disruptive to the meeting.

Limitations:

Although there is a statutory right to photograph and record Council meetings, the proceedings of that meeting must not be disrupted by the use of media tools and must not inhibit community involvement in the proceedings.

Audio and Visual Recording - Your Obligations

Any member of the public, or of the media, wishing to photograph or record a meeting is asked to comply with the following:

- a) any photography or audio/visual recording takes place from a fixed position in the meeting room approved by the Chair so as to reduce disruption to the proceedings;
- b) use of flash photography or additional lighting is for a limited period only during the meeting at a point in the proceedings agreed in advance with the Chairman;
- if the Chairman feels that any photography, audio or visual recording is disrupting the meeting in any way, or any pre-meeting agreement has been breached, then the operator of the equipment will stop;
- d) if, during the meeting, a motion is passed to exclude the press and public, because confidential or exempt information is likely to be disclosed, then all rights to record the meeting are removed and the operator of the equipment will be required to stop recording and/or photography;
- e) if a meeting is adjourned by the Chairman the operator of the equipment should stop any recording or photography at the point at which the meeting is adjourned;

- f) any request made by the Chairman regarding respecting the public's right to privacy is complied with;
- g) people seated in the public seating area should not be photographed, filmed or recorded without the consent of the individuals concerned. It is for the public to inform the Council, or the person recording, if they object.
- h) Use must not be made of an image or recording if consent is refused by a member of the public featured in that recording or image;
- i) Photographs, audio and visual recordings should not be edited in a way that could lead to misinterpretation of the proceedings. This includes refraining from editing the views being recorded in a way that may ridicule or show lack of respect.
